- 1. This form must be completed and submitted with supporting documentation if you wish to make corrections to the Employment Reported section of your Credit Report. Required fields are highlighted in red.
- Please complete all required fields in the 'Personal Information' section of the form and submit scans of the following documents to verify your identity: one piece of government-issued ID (confirming your name, date of birth, and/or address);; and one document confirming the name and address on the ID (e.g., Utility, Hydro, Phone, Cable, Internet, or Financial Statements).
- 3. Complete the required fields and the fields that need to be updated in the **'New/Updated Employment Record'** sections of the form, and submit documentation to support the requested update. Acceptable supporting documentation may include:
 - If you are an employee:
 - Letter of employment (dated less than 3 months

- If you are an owner or self-employed: Valid Business License
- Pay Stub (Dated less than 3 month) Artic
- Current T4 Slip / T4 Summary

- Article of Incorporation (Dated less than 1 year), please also provide 1 of the following documents:
 - Corporate Credit/Debit Card Statement (Dated less than 3 months)
 - Corporate Government Documents (Dated less than 3 months)
 - Corporate Utility Bill (Dated less than 3 months)
- 4. Scans of supporting documentation can be submitted by clicking on the links at the bottom of the page. We recommend that you **black out** any details that are not required to verify your identity or update your information.

Note: If you would like to add or change more than one employment record, a separate form will be required for each.
