



Auto Originations Observations

- 10.7 million auto loans and leases, totaling \$307.4 billion, have been originated year-to-date. This is a 0.9% increase in accounts and a 0.8% decrease in balances over this time last year.
- 1.75 million auto loans and leases have been originated YTD to consumers with a VantageScore® 3.0 credit score below 620. These are generally considered subprime accounts. This is a 1.6% increase from May 2023. These newly-issued loans have a corresponding total balance of \$40.9 billion, a 2.0% increase year-over-year.
- In May, 16.3% of auto loans and leases accounts were issued to consumers with a subprime credit score. This is the second lowest May YTD subprime share since 2010. May 2024 saw 13.3% of YTD balance share, which is lower than the same time last year.
- The average origination balance for all auto loans and leases issued in May 2024 was \$29,303. This is a 0.3% decrease from May 2023. The average subprime loan amount was \$23,970. This is a 0.4% increase compared to May 2023.



Total Balances Originated in \$Billions; NSA









Auto Average Origination Balance


Average Origination Balance Over Time; NSA Subprime accounts defined as those with borrower's origination VantageScore® 3.0 credit score less than 620

Auto Originations YTD



Auto Lease Originations Observations


Originations through May 2024 reported as of July 2024

- 1.27 million auto leases, totaling \$28.1 billion, have been originated year-todate. This is a 34.4% increase in accounts and a 31.0% increase in balances from this time last year. Auto leases accounted for 11.8% of all auto accounts originated through May and 9.1% of balances.
- Approximately, 87,580 auto leases have been originated YTD to consumers with a VantageScore® 3.0 credit score below 620. These are generally considered subprime accounts. This is a 38.4% increase from May 2023. These newly-issued leases have a corresponding total balance of \$2.02 billion, a 35.8% increase year-over-year.
- Through May, 6.9% of auto lease accounts and 7.2% of total balances were issued to consumers with a subprime credit score.
- The average origination balance for all auto leases is issued in May 2024 was \$22,002. This is a 3.0% decrease from May 2023. The average subprime lease amount was \$23,292, a 1.4% decrease over a year ago.

Note that lease origination values reflect the contract amounts only and exclude expected vehicle residual values.









Auto Loan Originations Observations

- 9.47 million auto loans, totaling \$279.3 billion, have been originated year-to-date. This is a 2.5% decrease in accounts and a 3.1% decrease in balances over this time last year.
- Auto loans represent 88.1% of all auto account originations and 90.9% of all auto origination balances YTD.
- 1.66 million auto loans have been originated YTD to consumers with a VantageScore® 3.0 credit score below 620. These are generally considered subprime accounts. This is a 0.1% increase from May 2023. These newly-issued loans have a corresponding total balance of \$38.9 billion, a 0.7% increase year-over-year.
- Through May, 17.6% of auto loans were issued to consumers with a subprime credit score, accounting for 13.9% of origination balances. In 2023 YTD the account share was 17.1% and balance share was 13.4%.
- The average origination loan amount for all auto loans issued in May 2024 was \$30,354. This is a 0.7% increase over May 2023. The average subprime loan amount was \$24,008. This is a 0.5% increase compared to May 2023.







Auto Loan Average Origination Balance


Average Origination Balance Over Time; NSA Subprime accounts defined as those with borrower's origination VantageScore® 3.0 credit score less than 620

Auto Loan Originations Year-to-date





US Bankcard Originations Observations

- 29.4 million bankcards have been originated year-to-date. This is a 10.1% decrease in new accounts from the previous year.
- Total bankcard credit limits originated YTD are \$176.8 billion. This is a 2.0% decrease from the previous year.
- Around 5.31 million bankcards have been issued YTD to consumers with a VantageScore® 3.0 credit score below 620. These are generally considered subprime accounts. This is an 8.9% decrease over the same period in 2023. These newly-issued cards have a corresponding total credit limit of \$5.12 billion, a 5.0% decrease from 2023 levels.
- In 2024 through May, 18.1% of new bankcards were issued to consumers with a subprime credit score, with their share of new total credit limits at 2.9%. For the same period last year, the subprime share of new accounts was 17.9% and 3.0% of new credit limits.
- The average credit limit for all bankcards issued in May 2024 was \$5,944. This is an 8.1% increase compared to May 2023. The average credit limit on new subprime cards was \$965. This is a 1.2% increase compared to May 2023.



Total Origination Credit Limits in \$Billions; NSA









Average Origination Credit Limit Over Time; NSA Subprime accounts defined as those with borrower's origination VantageScore® 3.0 credit score less than 620







Private Label Originations Observations

- 6.98 million private label cards have been originated year-to-date. This is a 19.3% decrease in new accounts from the previous year.
- The total credit limit originated YTD is \$20.7 billion, which is a 10.4% decrease from the previous year.
- YTD, 987,100 private label cards have been issued to consumers with a VantageScore® 3.0 credit score below 620. These are generally considered subprime accounts. This is a 24.1% decrease from 2023. These newly issued cards have a corresponding credit limit of \$916.1 million, a decrease of 21.4% from the same time last year.
- Through May, 14.1% of private label cards were issued to consumers with a subprime credit score. Credit limits on new subprime cards represent 4.4% of total new limits. For the same period one year ago, the shares were 15.0% of accounts and 5.1% of limits.
- The average credit limit for all bankcards issued in May 2024 was \$3,146. This is a 14.3% increase compared to May 2023. The average credit limit on new subprime cards was \$947. This is a 4.4% increase compared to May 2023.









Private Label Card Average Origination Credit Limit




YTD Private Label Origination Credit Limits



First Mortgage Originations Observations

- Over 1.68 million first mortgages have been originated year-to-date through May. This is a 1.9% decrease from the same YTD period in 2023.
- The total dollar amount of first mortgages originated YTD is \$565.7 billion, which is a 2.7% increase from the previous year.
- 109,200 first mortgages have been issued YTD to consumers with a VantageScore® 3.0 credit score below 620. These are generally considered subprime accounts. This is a 10.7% increase from 2023. These newly issued mortgages have corresponding total balances of \$25.5 billion, a 18.2% increase from the same period a year ago.
- Through May, 6.5% of first mortgages were issued to consumers with subprime credit scores and subprime mortgages represent 4.5% of new mortgage origination balances. In May 2023, the YTD subprime shares were 5.7% of accounts and 3.9% of balances.
- The average loan amount for all first mortgages originated in May 2024 was \$341,187. This is a 2.9% increase compared to May 2023. The average credit limit on new subprime first mortgage loans was \$218,554. This is a 3.0% decrease compared to May 2023.









First Mortgage Average Origination Balance


Average Origination Balance Over Time; NSA Subprime accounts defined as those with borrower's origination VantageScore® 3.0 less than 620

YTD First Mortgage Origination Balances





HELOC Originations Observations

- Around 492,100 HELOCs have been originated year-to-date. This is a 2.3% decrease from 2023.
- The total credit limit on HELOCs originated YTD is \$62.2 billion, a 0.3% decrease from the previous year.
- Around 23,290 HELOCs have been issued YTD to consumers with a VantageScore® 3.0 credit score below 620. These are generally considered subprime accounts. This is a 7.7% increase from the same period in 2023. These newly issued HELOCs have a corresponding total credit limit of \$1.45 billion, a 12.9% increase over the same period a year ago.
- Through May, 4.7% of HELOCs were issued to consumers with a subprime credit score and aggregated credit limits on new subprime HELOCs are 2.3% of total HELOC credit limits originated YTD. A year ago, the subprime shares were 4.3% of accounts and 2.1% of credit limits.
- The average loan amount for all HELOCs originated in May 2024 was \$125,631. This is a 4.7% increase compared to May 2023. The average credit limit on subprime HELOCs was \$64,594. This is a 5.4% increase compared to May 2023.









HELOC Average Origination Credit Limit


Average Origination Credit Limit over time; NSA Subprime accounts defined as those with borrower's origination VantageScore® 3.0 less than 620

YTD HELOC Origination Credit Limits





Consumer Finance Originations Observations

- 10.6 million consumer finance loans have been originated year-to-date. This is an 8.0% decrease from 2023.
- The total dollar amount of consumer finance loans originated YTD is \$46.2 billion, a 6.5% decrease from the previous year.
- Over 3.49 million consumer finance loans have been issued YTD to consumers with a VantageScore® 3.0 credit score below 620. These are generally considered subprime accounts. This is a 2.0% decrease from 2023. These newly issued loans have a corresponding total origination amount of \$9.2 billion, a 4.2% decrease from 2023.
- Through May, 32.9% of all consumer finance loans were issued to consumers with a subprime credit score. Origination credit limits on subprime consumer finance loans represent 19.8% of the total.
- The average loan amount for all consumer finance loans originated in May 2024 was \$4,509. This is a 3.6% increase compared to May 2023. The average loan amount on new subprime consumer finance loans was \$2,727. This is a 0.5% decrease compared to May 2023.









Average Origination Loan Credit Limit Over Time; NSA Subprime accounts defined as those with borrower's origination VantageScore® 3.0 credit score less than 620







- > 5.51 million consumer finance (CF) installment loans have been originated year-to-date. This is a 7.6% decrease from 2023.
- The total dollar amount of CF installment loans originated YTD is \$23.8 billion, a 2.5% decrease from the previous year.
- 2.58 million CF installment loans have been issued YTD to consumers with a VantageScore® 3.0 credit score below 620. These are generally considered subprime accounts. This is a 7.4% decrease from 2023. These newly issued loans have a corresponding total origination amount of \$7.84 billion, a 4.9% decrease from 2023.
- Through May, 46.8% of all CF installment loans were issued to consumers with a subprime credit score. Origination credit limits on subprime CF installment loans represent 33.0% of the total.
- The average loan amount for all CF installment loans originated in May 2024 was \$4,519. This is a 9.8% increase from May 2023. The average loan amount on new subprime CF installment loans was \$3,183. This is a 6.3% increase compared to May 2023.











Consumer Finance Revolving Loan Originations Observations Originations through May 2024 reported as of July 2024

- > 5.06 million consumer finance (CF) revolving loans have been originated year-to-date. This is an 8.7% decrease from 2023.
- The total dollar amount of CF revolving loans originated YTD is \$22.4 billion, a 10.5% decrease from the previous year.
- 907,300 CF revolving loans have been issued YTD to consumers with a VantageScore® 3.0 credit score below 620. These are generally considered subprime accounts. This is a 17.1% increase from 2023. These newly issued loans have a corresponding total origination amount of \$1.31 billion, a 0.3% decrease from 2023.
- Through May, 17.9% of all CF revolving loans were issued to consumers with a subprime credit score. Origination balances on subprime CF revolving loans represent 5.9% of the total.
- The average loan amount for all CF revolving loans originated in May 2024 was \$4,498. This is a 2.7% decrease from May 2023. The average loan amount on new subprime CF revolving loans was \$1,379. This is a 20.4% decrease compared to May 2023.







CF Revolving Average Origination Credit Limit



YTD Consumer Finance Revolving Origination Credit Limits





Student Loan Originations Observations

- 2.77 million student loans have been originated year-to-date. This is a 14.6% decrease from the same period a year ago.
- The total dollar amount of student loans originated YTD is \$35.2 billion, a 53.8% increase from the previous year.
- VantageScore® 3.0 credit score below 620. These are generally considered subprime accounts. This is a 5.9% decrease from 2023. These newly issued loans have a corresponding total origination amount of \$9.30 billion, a 72.4% increase from 2023.
- Through May, 34.9% of all student loans were issued to consumers with a subprime credit score. Origination balances on subprime student loans represent 26.4% of the total.
- The average loan amount for all student loans originated in May 2024 was \$12,791. This is an 80.2% increase compared to May 2023. The average loan amount on new subprime student loans was \$9,289. This is a 90.4% increase compared to May 2023.



Total Origination Balances in \$Billions; NSA









Student Loan Average Origination Balance





- Data are sourced from Equifax's U.S. Consumer Credit database of over 220 million consumers.

 - These data are population level not a sample.
 - Jointly held accounts are represented by a randomly selected borrower on the account. Tradelines are only counted once.
 - Exclusions for data quality are applied, such as timely reporting of the establishment of the trade (≤12 months); completeness of the tradeline record including type, credit limit, balance outstanding and status; and other similar filters (e.g., exclude if borrower's death reported).

Definitions: Account Type

- Auto Total: all accounts from banks and finance companies for loans or leases on light vehicles.
- Auto Lease: a long-term contract lease of the light vehicle that terminates with the return of the car or a balloon payment of the rest of the balance due. Lease amounts reported to Equifax reflect the contract amount only, excluding the expected residual value of the vehicle at lease end.
- Auto Loan: traditional amortizing installment loans on a light vehicle.
- Credit Cards Bankcard: general purpose credit cards.

- Definitions: Account Type, continued
 - Credit Cards Private Label: credit cards issued for use at particular retailers. Sometimes called retail cards or store cards.
 - First Mortgage: loans with first lien position on a residential property.
 - Home Equity Installment Loan: loans in second lien position on a residential property. These loans are amortizing for the full term of the loan and do not have a draw feature.
 - Home Equity Revolving Lines of Credit: loans usually in second lien position on a residential property. These loans commonly require only interest payments during the draw period and then are recast into amortizing payments at the end of the draw. During the draw period the borrower may take advances from the line of credit.
 - Total Consumer Finance: installment or revolving loans opened with a sales financing company or a personal finance company. These are typically unsecured finance trades.
 - Consumer Finance Installment: consumer finance loans that are amortizing for the full term of the loan and do not have a draw feature.
 - Consumer Finance Revolving: consumer finance loans with a line of credit from which the borrower can draw funds.
 - Student Loan: loan funded for the purpose of financing post-secondary educational study

- Definitions: Other
 - Credit limit: the maximum amount the borrower can access on the account. On installment
 accounts this is the original loan amount. On revolving accounts this is also known as the credit
 line or high credit.
 - Subprime: a loan characterized by a combination of factors that make it not-prime-credit quality, meaning that these loans will typically have higher default rates and higher loss rates on average than prime-quality loans from the same vintage. Within this report these are defined as loans extended to borrowers who at the time the loan was originated had a VantageScore® 3.0 credit score below 620.
- Data on new tradeline originations are subject to revision for up to 12 months due to lags in lenders and servicers reporting to Equifax.
 - Data for the most recent 12 months are grossed up for expected but as yet unreported new loans.
 - First Mortgage trade lines may be most affected by delays as servicing rights as well as the loans themselves are frequently sold after origination.
 - With the exception of first mortgage and home equity installment loans, at least 90% of expected new tradelines will have been recorded for the most recent month included in this report (e.g., October 2017 origination data in the October 2018 report).
 - Note that in February 2017 we permanently moved accounts that were previously identified incorrectly as home equity installment loans to consumer finance installment loans, affecting values after May 2014.
