# Sample Government Verification of Employment (GVOE) - CSF

For many government agencies, knowing whether a person is employed, and if so, where that person is employed, are two key pieces of information needed in order to provide appropriate assistance. Equifax leverages The Work Number® database, the largest repository of consolidated employment and income data, to instantly provide this information. In compliance with the Fair Credit Reporting Act (FCRA), Equifax requires anyone requesting a verification to have permissible purpose. Government agencies may need to verify employment information for pre-employment and debt collection purposes. The government verification of employment provides basic information about an employee's job, their employer, their title, employment status (active or inactive), and the length of time with the employer.
