### I-9 Management Updates - What's included in this release:

#### **Form I-551 Permanent Resident Card Expiration Extension**

When presented with an expired Form I-551 Permanent Resident Card or an Alien Registration Receipt Card with an *I-797 Notice of Action Receipt Notice of Form I-90*, the expiration date on the I-551 will be automatically extended to add 36 months. The Additional Information section of the Form I-9 PDF is populated with text indicating the permanent resident card had been extended and includes the I-90 receipt number from the Form I-797.

#### **Honduras - TPS EAD Extension**

The TPS Extension for Honduras results in an extension through **03/09/2025** based on the following criteria:

- The Form I-766 Employment Authorization Document (EAD) Card category of **A12** or **C19**
- Country of Origin equal to Honduras  
and
- Current expiration dates:

January 5, 2018	July 5, 2018	January 5, 2020	January 4, 2021
October 4, 2021	December 31, 2022	June 30, 2024

### **Nepal - TPS EAD Extension**

The TPS Extension for Nepal results in an extension through **03/09/2025** based on the following criteria:

- The Form I-766 Employment Authorization Document (EAD) Card category of **A12** or **C19**
- Country of Origin equal to Nepal  
and
- Current expiration dates:

June 24, 2018	June 24, 2019	March 24, 2020	January 4, 2021
October 4, 2021	December 31, 2022	June 30, 2024

### **Nicaragua - TPS EAD Extension**

The TPS Extension for Nicaragua results in an extension through **03/09/2025** based on the following criteria:

- The Form I-766 Employment Authorization Document (EAD) Card category of **A12** or **C19**
- Country of Origin equal to Nicaragua  
and
- Current expiration dates:

January 5, 2018	January 5, 2019	April 2, 2019	January 2, 2020
January 4, 2021	October 4, 2021	December 31, 2022	June 30, 2024

### **Sudan - TPS EAD Extension**

The TPS Extension for Sudan results in an extension through **03/09/2025** based on the following criteria:

- The Form I-766 Employment Authorization Document (EAD) Card category of **A12** or **C19**
- Country of Origin equal to Sudan  
and
- Current expiration dates:

November 2, 2017	November 2, 2018	April 2, 2019	January 2, 2020
January 4, 2021	October 4, 2021	December 31, 2022	June 30, 2024

### **Section 2: Required upload of front and back of List A documents for Locations Participating in E-Verify**

For employers or locations participating in E-Verify, it is required to upload images of the front and back of the employee-presented List A documents during Section 2 completion. The following List A documents require the front and back to be uploaded and retained by the employer:

- U.S. Passport Booklet
- U.S. Passport Card
- Form I-766 Employment Authorization Document (EAD) Card
- Form I-551 Permanent Resident Card
